CALL FOR BIDS- CONTRACT NO. 2202
WESTPORT MARINA GEARYARD RELOCATION AND EXPANSION

The proposal consists upgrading an existing gravel parking area along Yearout Drive in Westport, WA to a commercial gear yard. Work includes clearing and grubbing; grading of site and pavement of asphalt roadway, installing power distribution and telemetry systems for site access control, security, and lighting; low-impact stormwater facilities and security fencing. Contractor will provide all labor, materials, and equipment necessary to complete the work as specified.

Award will take into consideration the lowest total base bid price to provide the services specified along with qualifications and experience of the bidder and the Port's budget capability.

Bid documents will be available by 11:00 a.m. on Wednesday June 14th, 2023, through Builders Exchange of Washington. **Bids will not be accepted after 11:00:00 a.m. on Friday June 30th, 2023.**

All bid proposals shall be accompanied by deposit in cash, certified check, cashier's check, or surety bond in an amount equal to five percent (5%) of the amount of such bid proposal. Should the successful Bidder fail to enter into a contract and furnish a satisfactory performance bond, the bid proposal deposit shall be forfeited.

In accordance with RCW 42.56.100 and Port of Grays Harbor Resolution 2973, the Port makes the following rule:

Public Bid Guidelines require that the Port of Grays Harbor maintain the integrity of official bid documents sets, provide swift response when incorporating addenda changes, and communicate in a singular, fair, and equitable manner to registered bidders. This process would interfere with the Port's obligations to maintain the integrity of the bid records if the Port were required to relinquish control over the bid documents during the bidding period.

For this purpose, The Port of Grays Harbor has designated Builders Exchange of Washington (BXWA) as the official source of bid packages, which insures that all bidders receive complete documentation, including all addendum, changes, and clarifications. BXWA provides prime bidders, subcontractors, suppliers, and other interested parties, virtual free-of-charge access to a complete set of project bid documents, including the ability to download, view, print, order full/partial plan sets from numerous reprographic sources, and free access to an on line digitizer/take-off tool.

Access to bidding information (plans, specifications, addenda, and Bidders List) is available through the Port of Grays Harbor's on-line plan room. Free-of-charge access is provided to Prime Bidders, Subcontractors, and Vendors by going to www.bxwa.com and clicking on "Posted Projects", "Public Works", and "Port of Grays Harbor". This online plan room provides Bidders with fully usable online documents with the ability to: download, view, print, order full/partial plan sets from numerous reprographic sources, and a free online digitizer/take-off tool. It is recommended that Bidders "Register" in order to receive automatic e-mail notification of future addenda and to place themselves on the "Self-Registered Bidders List". Bidders that do not register will not be automatically notified of addenda and will need to periodically check the on-line plan room for addenda issued on this project.
